## Call for presenters about our Bullying Strand



At this year's State Parent Advisory Conference, SPAC parent volunteers are including a bully prevention strand. We are actively recruiting organizations and individuals that can contribute their expertise on this topic.

The idea for this conference's focus was prompted by the February release of the DVD entitled Bully: Fostering Empathy and Action in Schools directed by Lee Hirsch. Bullying is one of the most pervasive problems in our schools. This film is very powerful and honest. We will show the documentary following Tuesday's banquet. SPAC will also provide all parents with A Guide to the Film Bully that accompanies the film.

The Nation School Safety Center calls bullying "the most enduring and underrated problem in American schools." Bullying is commonly defined as one or more individuals inflicting physical, verbal, or emotional abuse on another person repeatedly over a period of time. Victims do not intentionally provoke these negative acts, and they have difficulty defending themselves. Bullying occurs every day in our schools regardless of size or socio-economic background.

Research shows that sixty percent of childhood bullies go on to commit adult crimes. They are inclined to have more convictions for drunk driving, to be more abusive to their spouses, to have children who become bullies themselves, and to experience less success in school and work. Bullying is not limited to sensational episodes that make the headlines and involve guns, knives, and bombs. More often bullying is less dramatic but it is, nonetheless, a source of isolation, depression, and fear for many students. Bullying undermines the efforts of school staff to create a climate that promotes student success, and it has a negative impact on all learners.

Strong leadership and an ongoing pledge from school administrators to promote safe schools for all students is a good start; however, the best safe school programs involve the coordinated efforts of administrators, teachers, support staff, parents, law enforcement officers, and community partners. Since bully/victim problems do not disappear at the end of the schools day, parental involvement is important in creating an environment in which all children feel safe, accepted, and valued. Parents should also be included in intervention and postvention efforts. They often have the same problems that teachers experience with their children at school. Guidance counselors can provide supports and link home and school intervention strategies to reduce bully/victim problems.
